| C3.2 | Facility Commitment Fee | During the availability period of a committed facility, bank will charge a commitment fee to compensate the cost of the funds committed but yet to be drawn by the customer. (waived for small/micro companies) | Facility Commitment Fee is collected from customer after the execution of facility agreement for a committed loan. Fee amount is calculated based on the amount of committed undrawn portion and time of the undrawn period by applying the commitment fee rate, ranging from 0.1% - 1%. |
